We worked hard to provide the best possible value-based programs and services to our community, which were needed more than ever during this economically and emotionally difficult year. We experienced many key developments in 2009:

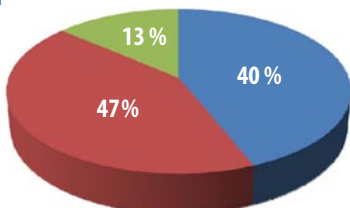
- Using contributions to our Annual *Partners with Youth* campaign, one out of every 20 members of our Y family received some form of financial assistance, an increase of 41% from 2008. We awarded 574 individuals financial assistance
- 120 volunteer coaches taught over 900 children soccer, tee ball and basketball in our leagues throughout the year
- Our Blue Waves Swim Team moved from Division IV to Division II for the 2009-2010 season and had their most successful season to date
- In a partnership with the City of Newton, the YMCA was able to begin offering off-site programming at the former Newton Corner Library Branch
- We laid the ground work for our *Advance the Legacy* campaign, the last phase of our decades-long renovation project to keep your YMCA strong and vital for many more generations to come
- Tab readers recognized the West Suburban YMCA, and we won #1 choice health club in Newton, regional silver health club, regional bronze weight loss center, and also regional bronze summer camp
- Over 1,300 children attended our summer camps
